This work included duties such as security upgrades, office space renovations, Data and Security Control Rooms for Federal Buildings, and related support systems such as climate controls, security systems and general construction. I negotiated with contractors regarding the price of projects and worked closely with the Federal Contracting Officers to ensure compliance with all Federal Acquisition Regulations (FAR). I also performed on site inspections of all projects to ensure contract compliance with the approved drawings and specifications. Aircraft runway construction of approximately 4000 meters for military aircraft, helicopters and drones to include ramps, signage/markings, lighting, hangers and command & control systems and facilities. Precast concrete high rise along with the interior finishes, fire alarms and fire protection systems were all part of this project. Some of the security systems that were completed consisted of traffic barriers, guard towers, and a Command and Control Security Building with automated controls, video cameras, and communication systems. I was responsible for performing the testing and functionality of all systems for contract compliance and system operation.
